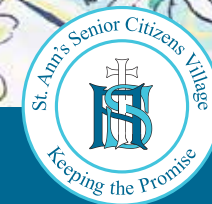

## CHOOSING THE RIGHT GIFT PLANNING OPTION

### Gift of Securities

You will benefit by receiving a charitable tax receipt for the full market value of your eligible securities and mutual funds when you transfer them to St. Ann's Senior Citizens Village Corporation. Donations of publicly traded securities are not subject to capital gains tax.

### Gift in Will

Include the St. Ann's Senior Citizens Village Corporation as a beneficiary in your Will. A charitable bequest will ensure your legacy lives on and by doing this you can also significantly reduce tax payable by your estate. We can provide sample Will clauses for your convenience.

### Gift of Life Insurance

Consider transferring ownership of an existing life insurance policy that is no longer required for your family's financial security to St. Ann's Senior Citizens Village Corporation. You will benefit from receiving a charitable tax receipt for the value of the policy. If you wish to remain the owner of the policy, your estate may receive a charitable tax receipt by naming St. Ann's Senior Citizens Village Corporation the beneficiary of the policy.

### Gift of RRSPs, RRIFs & TFSAs

You can name St. Ann's Senior Citizens Village Corporation as the beneficiary of your RRSP, RRIF or TFSA.
